Early Care is available Monday – Friday, 7 a.m. to 8 a.m. for \$5 per camper, per week
Late Care is available Monday – Friday, 5 p.m. to 6 p.m. for \$5 per camper, per week

PAYMENT AGREEMENT

By registering, you agree to the following:

1. Payment for the first week your child attends is due upon registration on or before June 12, 2010.
2. A \$15 non-refundable, non-transferable deposit is due upon registration for any additional weeks reserved.
3. If payment is not received by the due date, your \$15 deposit will be kept and your child’s spot will be lost.
4. A \$25 cancellation fee will be charged for weeks cancelled after due date of payment (see above).
5. There are no daily rates available.
6. A \$5 Early Care fee will be charged if child is dropped off before 8 a.m.
7. A \$5 Late Care fee will be charged if child is picked up after 5 p.m.
8. A late fee of \$10 per 15 minutes or fraction thereof will be charged if child are picked up after 6 p.m.
9. Refunds will not be issued for week(s) not cancelled before the start of the camp week.
10. A \$25 fee will be charged for all returned checks.
11. Returned checks must be cleared through City Hall within 3 working days of notification. If returned checks are not cleared within 3 working days, child may be suspended from attending program.
